

February 18, 2020

The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Tuesday, February 18, 2020, with Vice-Chairman Roberts presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Mark Roberts, Dr. Ken Rains, Ms. Lorri Mitchell, and Dr. Art Sixkiller. Mr. Garry Harris was absent.

A motion was made by Dr. Rains and seconded by Ms. Mitchell to approve the minutes of the Regular Meeting held February 3, 2020. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Mitchell, Sixkiller, and Roberts Nay – none

A motion was made by Dr. Sixkiller and seconded by Dr. Rains to approve Claims #868 - #930 totaling \$822,881.29 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Rains, Mitchell, and Roberts Nay – none

The Board recognized Mr. Jared Crisp who discussed the upgrade to the Nipak Lift Station and SCADA systems.

Mr. Crisp also reported two large payments were received, \$40,785.99 Mutual Aid payment from Collinsville, Oklahoma and \$10,000 GRDA Grant payment for Cost of Service Electric Rate Study.

Mr. Crisp discussed several compliance reports he is required to complete annually. He also reported he would be attending the GRDA Customer Group Meeting at NSU-Broken Arrow on Wednesday, February 19, 2020.

The Board recognized Mrs. Teri Hill who reported the Municipal Utility Board would be hosting the OGA (Oklahoma Gas Association) Board Meeting on Wednesday, February 19, 2020. She also reported Mr. Roger Eichelberger received the Oklahoma Municipal League Honor Roll of Service Award for 25 years of service to the citizens of Pryor Creek and she would be asking the Honorable Mayor Lees to present the award during the OGA Board Meeting.

A written Department Foreman's Report was presented.

Mr. Jared Crisp discussed and recommended the promotion of Mr. Travis Whitenack to "A" Mechanic with Merit, effective February 20, 2020.

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to promote Mr. Travis Whitenack from "A" Mechanic Non-Merit to "A" Mechanic with Merit (\$22.95 per hour to \$24.09 per hour), effective February 20, 2020.
