November 16, 2020

The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Monday, November 16, 2020, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Ms. Lorri Mitchell, Dr. Art Sixkiller, Mr. Mark Roberts and Dr. Ken Rains.

Guest attending included: Honorable Mayor Lees, Mr. Travis Willis, Mr. Ronnie Bowers, and Mr. Terry Aylward.

The Board recognized Mr. Jared Crisp who reported a change to Bid #928. Arkansas Electric delivered less 9.375 feet of Line Item 64 and an additional 750 feet of Line Item 66 for a total increase of \$1,753.52. The new total balance for Bid #928 is \$112,845.79.

A motion was made by Dr. Sixkiller and seconded by Dr. Rains to accept the total increase of \$1,753.52 for Line Items 64 and 66, which made \$112,845.79 the new total balance for Bid #928 and approve the minutes of the Regular Meeting held November 2, 2020. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Rains, Mitchell, Roberts, and Harris Nay – none

A motion was made by Dr. Sixkiller and seconded by Mr. Roberts to approve Claims #484 - #541 totaling \$811,072.33 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Roberts, Mitchell, Rains, and Harris Nay – none

The Board recognized the Honorable Mayor Larry Lees who had no report.

The Board recognized Mr. Ronnie Bowers of Hood & Associates CPAs, PC who reported Ms. Violet F. Kirkendall had a conflicting schedule and he would be presenting the Annual Audit for Fiscal Year Ending June 30, 2020.

Mr. Crisp recommended the Board accept the Annual Audit for Fiscal Year Ending June 30, 2020 as presented.

A motion was made by Dr. Sixkiller and seconded by Ms. Mitchell to accept the Annual Audit for Fiscal Year Ending June 30, 2020 as presented. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Mitchell, Roberts, Rains, and Harris Nay – none

The Board recognized Mr. Steve Powell (attending by Video Conference) who introduced an aerial photo of a proposed sewer interceptor from the proposed Salt Branch Sewer Extension to a development located on the eastside of Gaither Road. If the

discussions with the Land Developer, the Hydraulic Study for the City of Pryor Creek, and the proposed Salt Branch Sewer Extension continue to be favorable, then he will prepare a formal presentation of the proposed sewer interceptor introduced in the aerial photo.

Mr. Powell also updated the Board on the Wastewater Treatment Plant Notice of Violation No. S-21623-20-1 from the Oklahoma Department of Environmental Quality regarding the failure to submit the required Whole Effluent Toxicity (WET) Test in a timely manner. The test was well within the limits and the late submittal was an oversight by Staff due to a COVID related leave. Mr. Crisp added the consequence for the negligent oversight would be the requirement of quarterly testing for a minimum of two years instead of the previously achieved bi-annual requirement.

Mr. Powell reported on the 14th Street and Fairland Street Drainage Project.

The Board recognized Mr. Crisp who discussed the rise in active COVID cases in the City of Pryor Creek and in Mayes County and the mandated CDC guidelines. Mr. Crisp reported on a change in operations that excluded himself and a Serviceman. Beginning November 23, 2020 through January 1, 2021 all departments would be split in one-half and alternate scheduled work weeks to protect the health of our organization so we can continue to provide reliable services to the customers.

The Board recognized Mrs. Teri Hill who had no report.

A written Department Foreman's Report was presented with no additional comments.

The Board recognized Mr. Jared Crisp who reported all of the promotions listed on Agenda 6c through 6k were requested in writing by their respective supervisors and he recommended the Board's approval for all.
