



May 15, 2023

The Municipal Utility Board met in a Regular Session at 6:00 p.m. on Monday, May 15, 2023, with Chairman Harris presiding. The agenda was posted in the outside Pryor City Hall Bulletin Case at 12 North Rowe Street. Members present were: Mr. Garry Harris, Dr. Ken Rains, Ms. Lorri Mitchell, Dr. Art Sixkiller, and Mr. Mark Roberts.

Mr. Terry Aylward of The Paper was the only guest in attendance.

A motion was made by Dr. Rains and seconded by Ms. Lorri Mitchell to approve the Minutes of the Regular Meeting held May 1, 2023. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Mitchell, Roberts, Sixkiller, and Harris.

A motion was made by Dr. Sixkiller and seconded by Mr. Roberts to approve Claims #1288 - #1351 totaling \$1,074,435.69 for payment. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Roberts, Mitchell, Rains, and Harris Nay – none

The Board recognized Mr. Steve Powell, P.E. of Infrastructure Solutions Group, LLC who updated the Board on the SCADA installation at the Chlorine Contact Basin by Mr. R. W. Vaught.

Mr. Steve Powell also updated the Board on the low pressure testing of the water system near Gaither Road and Old Airport Road which confirmed the need to implement improvements to the water system. Mr Powell also updated the Board on the B & H Lift station and force main improvements.

Mr. Steve Powell reported on the channelization project for Salt Branch on Dr. Nunley's property which will also address the erosion issue and reinforcement of the sanitary sewer main.

Mr. Steve Powell reported he would be taking an extended leave of absence during the month of June through mid-July and he had made provisions with his staff to attend Board Meetings in his absence.

The Board recognized Mr. Jared Crisp who discussed Resolution No. 2023-01, A Resolution of the Municipal Utility Board of the City of Pryor Creek, Oklahoma and recommended the Board authorize the execution of the agreement establishing The Oklahoma Municipal Natural Gas Coalition.

A motion was made by Ms. Mitchell and seconded by Mr. Roberts to approve Resolution No. 2023-01, A Resolution of the Municipal Utility Board of the City of Pryor Creek, authorizing execution of the agreement establishing The Oklahoma Municipal Natural Gas Coalition. MOTION CARRIED. Votes cast as follows: Ayes – Mitchell, Roberts, Sixkiller, Rains, and Harris Nay – none

Mr. Jared Crisp reported the Pryor Creek City Council approved the recommendation to pass through a decrease in natural gas rates inside city limits during the May 2, 2023 Regular Council Meeting and recommended the Board decrease the natural gas rates inside city limits from \$11.246 per MCF to \$10.724 per MCF effective May 2023 billing due June 1, 2023.

A motion was made Dr. Rains and seconded by Mr. Roberts to decrease the natural gas rates inside city limits from \$11.246 per MCF to \$10.724 per MCF effective May 2023 billing due June 1, 2023. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Roberts, Mitchell, Sixkiller, and Harris Nay – none

Mr. Jared Crisp discussed and recommended the Board approve the same pass through decrease of \$0.522 per MCF to the natural gas rates outside city limits.

A motion was made by Dr. Sixkiller and seconded by Dr. Rains to decrease the natural gas rates outside city limits from \$12.546 per MCF to \$12.024 per MCF effective May 2023 billing due June 1, 2023. MOTION CARRIED. Votes cast as follows: Ayes – Sixkiller, Rains, Roberts, Mitchell, and Harris Nay – none

Mr. Jared Crisp discussed the audit rate of \$5,000.00 for FY2008, the audit rate of \$4,750.00 from FY2009 through FY2013, the rate of \$4,250.00 for FY2014 through FY2022 and excellent working relationship between MUB and Ms. Violet Kirkendall. Then Mr. Crisp reported the 20% cost increase to perform the Annual Audit for Fiscal Year ending June 30, 2023 and recommended the Board authorize Ms. Violet Kirkendall of Hood & Associates CPAs, PC to perform the Municipal Utility Board Annual Audit at a cost not to exceed \$5,300.00.

A motion was made by Mr. Roberts and seconded by Dr. Sixkiller to authorize Ms. Violet Kirkendall of Hood & Associates CPAs, PC to perform the Municipal Utility Board Annual Audit for Fiscal Year ending June 30, 2023 at a cost not to exceed \$5,300.00. MOTION CARRIED. Votes cast as follows: Ayes – Roberts, Sixkiller, Rains, Mitchell, and Harris Nay – none

Mr. Jared Crisp reported he was preparing for the Budget review with the Budget Committee (Dr. Ken Rains and Ms. Lorri Mitchell) at 8:30 a.m. on May 23, 2023.

The Board recognized Mr. Travis Willis who reported the Purple Wave Online Auction bid for the 1989 Carrier King Inc. Model 1200 Steel Bed Trailer was currently at \$2,600.00 and was scheduled to close May 16, 2023.

Mr. Willis also reported the crews were staying busy as the weather would allowed.

The Board recognized Mrs. Teri Hill who had no report.

A written Department Foreman's Report was presented with no additional comments.

The Board recognized Mr. Jared Crisp who discussed and agreed with Mr. Jimmy Martin's recommendation to promote Mr. Robert Wilkerson to B Mechanic with Merit in the Water/Sewer Department effective May 11, 2023.

A motion was made by Dr. Rains and seconded by Mr. Roberts to promote Mr. Robert Wilkerson to B Mechanic with Merit (\$24.27 per hour to \$24.79 per hour) in the Water/Sewer Department effective May 11, 2023. MOTION CARRIED. Votes cast as follows: Ayes – Rains, Roberts, Sixkiller, Mitchell, and Harris Nay – none

Mr. Jared Crisp discussed and recommended the Board approve the purchase of a 2023 Bush Hog 1812 from Chupp Implement Co. at a price not to exceed \$16,999.00, which is less than the State of Oklahoma Central Purchasing Price.
